This certification will allow the public to sample your creations as well as sell any dishes/items you choose. The temporary license should cost you \$30.00. Each team will pay an entry fee of \$35.00. You will be given FOUR SECRET INGREDIENTS to be used. ALL dishes must be cooked with wood or charcoal. NO PROPANE. Judging will be by a panel of 5 local celebrity judges. FOUR SECRET ingredients will be given to each team to create dishes. Two reveals each morning.

\*PRIZES AWARDED: \$200 for each winning dish from each of the categories (Fruit, Vegetable, Protein and Wild Card) and \$200 for FAN FAVORITE. Donations for Fan Favorite may NOT be accepted until the start of the event. There will be FOUR additional trophies & \$100 cash awards given, which will be chosen by YOU the TEAMS. The additional \$600 will be awarded to the overall points winner.

\*Overnight camping is permitted.

\*No pets—unless there will be NOTHING to clean up after the event. (Issues in the past)
